Registration: 2012 Midwinter Meeting

As of January 13, 2012, advance registration for the Midwinter Meeting was 4,823. This compares to 5,180 at the same point last year (2011 Midwinter Meeting, San Diego). Registrants include 95 international attendees.

There are 3,269 exhibitor personnel registered, from 430 exhibiting organizations, with 82,000 net square feet of exhibit space.

BE INFORMED & JOIN THE DISCUSSION: HOT TOPICS

Copyright

There has been much activity in recent weeks on so-called anti-piracy bills in the U.S. Senate and U.S. House of Representatives. In the House, H.R. 3261, the “Stop Online Piracy Act,” (SOPA), introduced by Rep. Lamar Smith (R-TX) back in October is still being marked up by the Judiciary Committee. Markup will continue once the House returns on January 17, 2012. Debate of the proposed amendments by members of the committee has been impassioned.

Meanwhile, the Senate’s PROTECT IP Act of 2011 (S. 968), or PIPA, bill is on the move too. Introduced back in May of 2011 by Sen. Leahy (D-VT), cloture was filed on December 17 to proceed to a roll call vote on the bill scheduled for January 24, 2012 (the first day the Senate is back in session in the new year).

- **Privacy/Surveillance**

The SOPA bill (above) also raises very serious privacy problems. There is much interest within the ALA Committee on Legislation and among some Council members to develop a resolution around SOPA – including the copyright, access and privacy problems in the bill.

- Washington Office Update: *Orphaned Works & Digital Libraries* (Saturday, January 21, 8:00-10:00am, DCC – C146). Two consecutive panels will discuss two hot topics and take questions from the audience. The first panel (8:00-9:00am) will examine the current state of orphaned works. Panelists will discuss how institutions are “unlocking” orphans, best practices in doing so and possible paths forward. The second panel (9:00-10:00am) will review the landscape of digital libraries, including the HathiTrust Digital Library, Internet Archive and the proposed Digital Public Library of America. Panelists will discuss how the models work, ways in which they differ, and how each digital library is approaching orphaned works.

Confirmed speakers include Kevin Smith (Duke University), Dwayne Buttler (University of Louisville), Brewster Kahle (Internet Archive), Mary Minow (LibraryLaw) and Dave Hansen (Digital Library Copyright Project, University of California-Berkeley).

Organizers are Gwen Glazer (“Digitizing Hidden Collections”) and Jason Kucsma (co-editor, *Digitization in the Real World*)

Internet Content

While the ALA Office for Intellectual Freedom and other ALA units seek to publicize the 99.9% of public library success stories – stories about services to children, immigrants, seniors and others, the .1% -- the problems with users and Internet “porn” – have lately been getting the space. Consequently, OIF and the ALA Public Information Office are working on a document to guide members on this issue when they are talking to the press, their trustees, or their general community. No document is available yet – but ideas will be discussed at the Intellectual Freedom Committee meeting on Saturday, January 21, at approximately 10:00am, in the Dallas Convention Center, A309. Please note that this is not a formal hearing but the beginnings of a discussion on how ALA can offer the press and its members an understanding of ALA’s principles and practical advice on this issue.

Library Funding

Washington Office Update Breakout I: How to Save Your Library Using Grassroots Strategies (Saturday, January 21, 10:30am-noon, DCC – C141). Net Neutrality

On November 10, 2011, the U.S. Senate voted on S.J. Res. 6, an *anti*-net neutrality bill to overturn the Net Neutrality decision adopted by the Federal Communications Commission (FCC). The resolution was *defeated* in a partisan vote – 46 yeas and 52 nays. The bill’s demise allowed the FCC order upholding net neutrality to take effect November 20, 2011.

Privacy

The ALA Office for Intellectual Freedom continues its work on ALA’s “Privacy for All” initiative, an ongoing campaign to engage librarians in public education and advocacy to advance privacy rights and civil liberties in the digital age. “Choose Privacy Week,” (May 1-7, 2012) will focus on deepening public awareness about the serious issue of government surveillance and its impact on individual privacy rights. Posters, bookmarks and buttons are available now through the ALA Store (<http://tinyurl.com/CPW2012goods>) and additional programming materials will be available in March and April through the initiative’s website: <http://www.privacyrevolution.org>. The “Privacy for All” initiative is funded by a generous grant from the Open Society Foundations.

In addition to “Choose Privacy Week,” OIF is working to develop programming tools that will help libraries reach out to library users, young persons, and immigrant and refugee communities about privacy issues. An important component of this effort is an ongoing survey to assess librarians and library workers’ attitudes about privacy, both within and outside of the library. The Office for Intellectual Freedom is inviting librarians and library workers to participate in a new survey (building on an earlier 2008 survey) that will measure librarians’ attitudes about privacy rights and protecting library users’ privacy. All responses are anonymous and confidential. The survey is online at <http://tinyurl.com/ALAprivacysurvey> and takes about 15 minutes to complete.

Scholarly Communication

The potential for using the digital environment to accelerate scholarship depends not only on unfettered access to publications and data, but also – equally – on having the clearly stated rights to use and re-use materials. Only with full re-use rights are we able to realize the true potential of Open Access to create new knowledge, build on earlier findings, and translate research for educational and commercial use. The 2012 Midwinter SPARC/ACRL forum, “*Getting the rights*

right for the future of scholarly communication,” will explore the troubles of getting the rights pieces wrong and how we can unlock the future of scholarship and scholarly communication if we get the rights pieces right. The forum will be held from 4:00-5:30pm, Saturday, January 21, Dallas Convention Center, Room A201/A202. The ACRL Scholarly Communication discussion group will continue exploration of the issue from 4:00-5:30pm, Sunday, January 22, Sheraton Dallas, Room Majestic 05.

School Libraries

- The School Library Task Force (SLTF) is in the process of coordinating home office visits for each U.S. Senator in all 50 states. The visits are part of an ongoing effort to ensure that school libraries are included in the reauthorization of the Elementary and Secondary School Act (ESEA). School libraries were left out of the most recent version of the bill that passed the Senate Health, Education, Labor and Pensions Committee. Now that the bill can be debated on the floor, it is crucial to get school libraries included in the bill through an amendment. Coalitions making visits in each state are being tasked with asking their senators to sign on to a letter indicating their support for school libraries in ESEA. The SLTF is suggesting that each coalition include a school librarian, student, parent, local business person, and public librarian. But, all library supporters are certainly welcome. The School Library Task Force will meet from 4:30-6:30pm on Saturday, January 21, in the Dallas Convention Center, A3 Table 1.
- The 2011-2012 Presidential Task Force on School Libraries is actively supporting the White House petition on school libraries, initiated by Carl Harvey, 2011-2012 AASL president. It specifically petitions the Obama administration to “ensure that every child in America has access to an effective school library program.” 25,000 signatures, no later than February 4, 2012, are required in order for this petition to be viewed by White House staff. The Task Force asks that you not only sign this petition but spread the word to member groups and to your colleagues, as well as library supporters in your personal circles. The Task Force will be distributing information about the petition, with URLs and QR codes, through the ALA Midwinter Meeting. Materials will be available at the Membership Pavilion on the exhibit floor. In addition, a computer kiosk dedicated to the online petition will be available in the registration area. Value of Academic Libraries

Academic libraries and librarians are increasingly called upon to demonstrate their value to the campus community and plan for a rapidly changing future. Join the Association of College and Research Libraries (ACRL) for two open forums to explore these pressing issues.

- Learn about recent developments with ACRL’s *Value of Academic Libraries Initiative*, a multiyear project designed to aid academic librarians in demonstrating value, 10:30am-noon, Sunday, January 22, Sheraton Dallas Hotel, Lone Star Ballroom A1. In late fall 2011, ACRL joined with three partners – the Association for Institutional Research, Association of Public and Land-grant Universities, and the Council of Independent Colleges – to convene two national summits to determine the professional competencies that librarians need for the future. In this forum, learn the advice given by those attending the summits: college and university chief academic officers, senior institutional researchers, representatives from accreditation commissions and higher education organizations, and academic librarians.
- A major component of the assessment and value process is providing quality services to library users. To assist with this process, ACRL released a newly revised and updated version of the Standards for Libraries in Higher Education in October 2011. Learn how

these standards differ from previous standards and about the services ACRL will offer to support librarians in applying the standards for the purposes of strategic planning, program review, and institutional effectiveness. The forum will be 8:00-10:00am, Saturday, January 21, Sheraton Dallas Hotel, Houston Ballroom C.

Late Breaking News: The Research Works Act

A new bill, The Research Works Act (H.R. 3699), designed to roll back the NIH Public Access Policy and block the development of similar policies at other federal agencies, was introduced into the U.S. House of Representatives. Co-sponsored by Darrell Issa (R-CA) and Carolyn Maloney (D-NY), the bill would prohibit federal agencies from conditioning their grants to require that articles reporting on publicly funded research be made accessible to the public online. This would rollback the strides made by the library community in seeking public access to federally-funded research reports.
