Update from ALA Executive Board (Dora Ho)

-5581, way ahead of Seattle

-57300, for membership. About 500 less; understandable due to the decrease in librarianship

-2013 ended with a small budget surplus achieved through expense reductions

- ALA got a 2% one time increase. Budget committee working on 2015 budget
- Advocacy events check your Cognotes. A variety of approaches and signature gathering is happening
- National campaign for School Libraries happening in March

- LSTA grant increase to \$180 million for state libraries
- ALA got a \$1.5 million grant from Gates foundation. Helping with training libraries and librarians in community engagement
- Pres Elect Courtney Young will be working on initiative to help increase members
