Analysis of the following SCOE Recommendation on Round Table Membership:

Recommended Change:

"Increase the minimum number of dues-paying members needed to create a round table to one percent of ALA's membership unless identified as a strategic priority by the Board of Directors. Membership numbers will be revisited and averaged over a period of three years. Current round tables will be able to remain intact for the first three years to provide them the opportunity to grow their membership. This will provide round tables with more fiscal stability and the resources to accomplish their mission-driven goals." (SCOE Final Report to Board June 2020 - page 21)

Current ALA Bylaws (Article VII. Section 1.a.)

The Council may authorize the organization as a round table of any group of not less than 100 members of the Association who are interested in the same field of librarianship not within the scope of any division, upon petition of such group which shall include a statement of purpose.

Impact Analysis:

A 3-year average was calculated using the total member counts for ALA and the round tables as of August 31st for years 2017-2019. Round tables that have more than 567 members (1% of 56,734) are noted below in green. EMIERT, FMRT, GAMERT, GNCRT, IFRT, IRRT, LIRT, LRRT, NMRT, RRT, SRRT, and SUSTRT are the 12 round tables that will not be impacted by this recommendation.

The following 8 round tables are noted below in red and are currently at risk as they have less than 567 members, therefore impacted by this recommendation:
