First Activity

One item of new business was introduced and conducted over SAC's committee list in November through December 2021. The committee approved a collaboration with the ALA Graphic Novels and Cataloging Round Table (GNCRT) Metadata and Cataloging Committee. The purpose of this group is to expand on "special provisions" to LC"s Subject Heading Manual instruction H1430 (Comics and Comic Characters). A draft of the proposal was made available during the "midwinter" meeting (January 2022), and voted upon by email in the week following the meeting.

Second Activity

The committee voted to close the charge of the SAC Working Group on Alternatives to LCSH "Illegal aliens," which was formed in June 2019. There had been some discussion on keeping the working group open for the purposes of creating a clearinghouse of alternative practices for handling controversial subject terms. The consensus was that this avenue may be better pursued under a separate charge. More discussion on the clearinghouse idea will take place on the committee's email list.
