BACKGROUND:

The ALA Allied Professional Association (ALA-APA) is a nonprofit professional organization established "to promote the mutual professional interests of librarians and other library workers." To that end, the ALA-APA is focused on two broad areas:

- Certification of individuals in specializations beyond the initial professional degree.
- Direct support of comparable worth and pay equity initiatives, and other activities designed to improve the salaries and status of librarians and other library workers.



CPLA Program

The Certified Public Library Administrator (CPLA) Program is a voluntary post-MLS certification program for public librarians with three years or more of supervisory experience. Its aim is to further professional education and development and help librarians move to a higher level of practical professional experience. To date, there are a total of **320** enrollees in the program and **103** graduates.

LSSC Program

The Library Support Staff Certification (LSSC) Program offers library support staff the opportunity to commit to professional development and continuing education through the completion of competency sets developed and implemented by the ALA-APA. To date, there are a total of **629** enrollees in the program and **214** graduates.

APA @ PLA

Kimberly Redd, MSHTM, APA Program Manager for Certification & Talent Development, will be attending the PLA National Conference in Nashville, TN, February 25-29, 2020. APA will have a booth presence. The goal is to introduce a whole new audience of library workers to the products and services offered by APA.

2020 Salary Survey

The data collection phase of the online version of the 2020 edition of the *ALA-APA Salary Survey: Librarian – Public and Academic*, is in its final stages. The database will be available in early spring. Counting Opinions (SQUIRE) Ltd, is the vendor who conducted the survey and as previously stated, for the first time ever this will be a benefit free to all ALA members.

National Library Workers Day (NLWD)

This year's celebration of **National Library Workers Day** (**NLWD**) will be held on **April 21, 2020** and we are encouraging individuals, groups, and libraries to celebrate.

The original resolution for the celebration of NLWD was proposed to recognize the hard work, dedication, and expertise of librarians and library support staff. It was proposed that the Tuesday of National Library Week be designated the day; and, that on that day, interested library workers, library groups, and libraries should advocate for better compensation for all library workers.
