for the IFRT Executive Committee meeting on April 7, 2021

EASC meets monthly to plan, deliver, and evaluate educational programming on behalf of the round table.

The next EASC-hosted event will be an IFRT Reads featuring Oboler Award-winner Henry Reichman's book, *The Future of Academic Freedom*, during April 2021. Look for further announcements via Connect and IFRT social media. We will have a live discussion featuring Henry Reichman on Friday May 7th at 5PM Central Time!

On February 26, 2021, EASC hosted the webinar panel, *Frosty Windows, Frosty Mirrors: Representation, Labeling, Discoverability, and the Chilling Effect.* The event was moderated by Martin Garnar and featured seven panelists - Loida Garcia-Febo, Rhonda Evans, Amanda Vazquez, Laura Koltutsky, Rae-Anne Montague, Shannon Oltmann, and Desmond Wong - sharing of their expertise and experiences with social justice and intellectual freedom. 423 people registered for the event, which the Publications and Communications Committee promoted via social media, Connect, and the Intellectual Freedom Blog. There were 251 unique logins during the live event, and the event recording

The checklist was extremely useful as both an event promotion tool, and also an event planning tool. From our experience, we recommend adding an Intellectual Freedom Blog post as an additional event promotion outlet; and adding consent to record, contributor honoraria, and event evaluation considerations as host committee responsibilities in the event planning section of the checklist.
