EXECUTIVE DIRECTOR'S REPORT, ALA-APACD#5 and ALA-APA CD#6. Upon request from ALA-APA Executive Director Mary Ghikas, the ALA-APA Council allowed Lorelle Swader, ALA-APA Director, to provide the following update on the ALA-APA activities:

Certification programs. For the Certified Public Library Administrator program (CPLA), there are approximately 301 enrollees and 97 graduates. For the Library Support Staff Certification (LSSC), there are 560 enrollees and 183 graduates.

National Library Workers Day (NLWD). NLWD 18 will take place April 10, 2018. This day advocates for the work of all staff in libraries, including trustees and friends, without which productive and transformative libraries would not be possible. This year will include new proposals. With collaboration from the graphics department, products are available in the store and can be purchased year- round.

Equal Pay Day. Originated by the National Committee on Pay Equity in 1996 as a public awareness event to illustrate the gap between men's and women's wages. It represents the day in the year up to which women must work to catch up with the salaries men made in the previous year. This year, National Library Workers Day and Equal Pay Day coincide on April 10. Michele Leber, current president of the National Committee on Pay Equity, has been a tireless advocate for this cause. Support can be shown by wearing red on this day.

Digital download poster. The catalog this year will include a digital download poster, which can be tailored to share information with the public and people being served.

Sexual harassment policies. ALA policies related to sexual harassment direct offices, divisions, and other units to be advocates and support systems to people experiencing harassment. In collaboration with the Committee on the Status of Women in Leadership, the HRDR Advisory Committee, and the ALA-APA, work is being done to update these materials and make them more readily available.

ALA-APA TREASURER'S REPORT, ALA-APACD#4-4.1. Treasurer Susan H. Hildreth reported FY 2017 year-end results and provided a FY 2018 budget update.

FY 2017 Year-End Results: ALA-APA did very well in FY 2017. Both revenue and expenses were lower than in 2016. Net revenue at the end of FY17 was \$45,187, up approximately \$22,000 from 2016. Hildreth provided additional comparison between 2016 and 2017. Steady progress has been made in repaying the 2009 loan from ALA. After loan repayment, which will result in a loan balance of \$41,457, ALA-APA has approximately \$5,000 available in the budget for new initiatives.

FY 2018 Budget Update: Hildreth provided information on net revenue, expenses, and revenues for four months ending 12-31-17. While revenue is slightly lower than projected, expenses are also lower, resulting in a net revenue that is \$6,000 higher than the projected budget. Stable, if not growing, net revenues for ALA-APA are anticipated for 2018.

ADJOURNMENT. This meeting was adjourned upon the completion of the agenda.
