### 2. Team Report Outs

- **New Members and Mentorship Team** – reporting out: Martha Parker
  - Have been sending welcome letters to new residents.

  - Met earlier this summer to try to codify membership and plan goals.

### 3. Plans for Midwinter 2016

- Nataly proposed sending a monthly update e-mail in which teams can provide any updates, calls to action, resident highlights, etc. Attendees agreed this would be a good idea. Nataly will be working on a template for this e-mail.

- Nataly proposed outlining the RIG mentorship program at the RIG meeting at [ALA Midwinter 2016](#). Other initial ideas include looking at what other groups are doing (e.g. [LLAMA Mentoring Program](#)) and assessing program as it progresses. Depending on interest, RIG can continue to offer its own formal program, and/or help pipeline residents to other mentoring opportunities.
- Nataly and the other RIG officers proposed creating a year-long task force to update the [Resources page](#) to make it more useful for residents and residency coordinators. Attendees agreed this would be a good idea. More information on this, including forming this task force, to come at ALA Midwinter 2016.

#### 4. Diversity Alliance Institute

- Dominique, Tarida, and Orolando spoke about the first [Diversity Alliance](#) (DA) Institute, held at West Virginia University this past September. Currently, the DA consists of eight residents from four institutions—American University, University of Iowa, Virginia Tech, and West Virginia University—with the goal of not only recruiting, but especially retaining (i.e. the “pipeline” issue) early career librarians of color. Elements of the program include: three-year residencies, professional development funding, flexibility as to how individual residencies are structured (e.g. when/how rotations are scheduled).
- In the future, the DA is hoping to invite other institutions to join them. They are working on the criteria for participation, including residency requirements, timelines, annual Institute attendance and hosting, etc.
- Dean Jon Cawthorne (West Virginia University) is hoping RIG can be involved and help support the DA, including investigating what the DA is doing and providing an official statement of endorsement. - Attendees expressed initial (unofficial) interest in supporting the DA, but RIG officers will also need to check with ACRL itself on any official endorsement policies.
