Statement of Professional Concerns:

As we seek to solidify our new structure ready for a membership vote, I see the newly imagined Executive Board as especially important in reflecting our new, more effective structure. These last five years of the SCOE/Forward Together/TAG era have demonstrated how thoughtful and invested ALA leadership is, leadership including many beyond Council who have spent many thoughtful hours of discussion. I have watched and joined the association's deep self-examination as we seek to redefine how to best represent the needs of our membership and to forward the library profession in the face of outside forces that would negate much of what we do.



Advocacy is a core value driving the function of ALA, and the EB offers one face of that advocacy. Much of my work since I "retired" has been in the advocacy arena, specifically at the local level supporting the reconstitution of school libraries in the Houston Independent School District. While I have always worked on advocacy initiatives within AASL and ALA, the Houston Students Need Libraries effort was intensely hands-on, focusing on an audience that largely saw no need to restore libraries to the campuses. And we succeeded–school librarians were added as required staff members in every school in fall of 2022. Just as here at ALA with TAG, persistence has been key – I am certainly persistent.

Over my 44 years of membership, I have held many roles in ALA, especially AASL. But my most recent work with the ALA Ecosystem Initiative has clarified my understanding of our need within and beyond ALA to encourage librarians to speak with ONE VOICE, to reach both across our siloes internally and to the non-librarian public whether those are legislators or patrons. I appreciate how easy it is to focus on our personal niche while losing track of the bigger picture and I see much more how to use our individual professional perspectives collaboratively to expand our combined impact. I look forward to working with the EB to facilitate this Ecosystem ONE VOICE focus to the advantage of all of ALA. Our ecosystem needs to be inclusive of all our perspectives, representative of the changes we want to see in our world, and easily understood by the uninformed . Collaboration is essential – I work best when collaborating with a knowledgeable and persistent team, which I know the EB will be.

I also sit on the Board of the Freedom to Read Foundation. In the current climate where censorship of many kinds is favored by a loud minority, ALA is leading efforts to rebuild public awareness of the Right to Read and our collaboration with FTRF is key in this effort. ALA members hold more core values than just Intellectual Freedom, but in 2022-23, the other values are supporting our very public focus on Intellectual Freedom and First Amendment Rights. I am proud to stand with ALA and FTRF members to amplify the message that "Free People Read Freely."

ALA is strong in the face of naysayers. ALA staff and officers work tirelessly to advance the association's mission. I look forward to standing with them to respond thoughtfully, wisely, and with appropriate speed to decisions that come to the Executive Board.
