Annual report from the *LRTS* Editor to the Core Board of Directors
Report covering v. 64 and 2020 editor activities

(1) Status of Submissions

A total of twenty-eight papers were submitted to the journal for the period of January 1-December 31, 2020. The status of current submissions is shown below in table 1. This is a decrease from 2019, for which a total of thirty-two papers were submitted to the journal. Figure 1 provides a graphic view of submissions.

*Reasons for rejection include weak research methods, unacceptable presentation and/or failure to format paper using the *Chicago Manual of Style, 17th edition*, lack of essential elements of a research paper, or out of scope topic.

Figure 1. Status of Submissions January 1-December 31, 2020

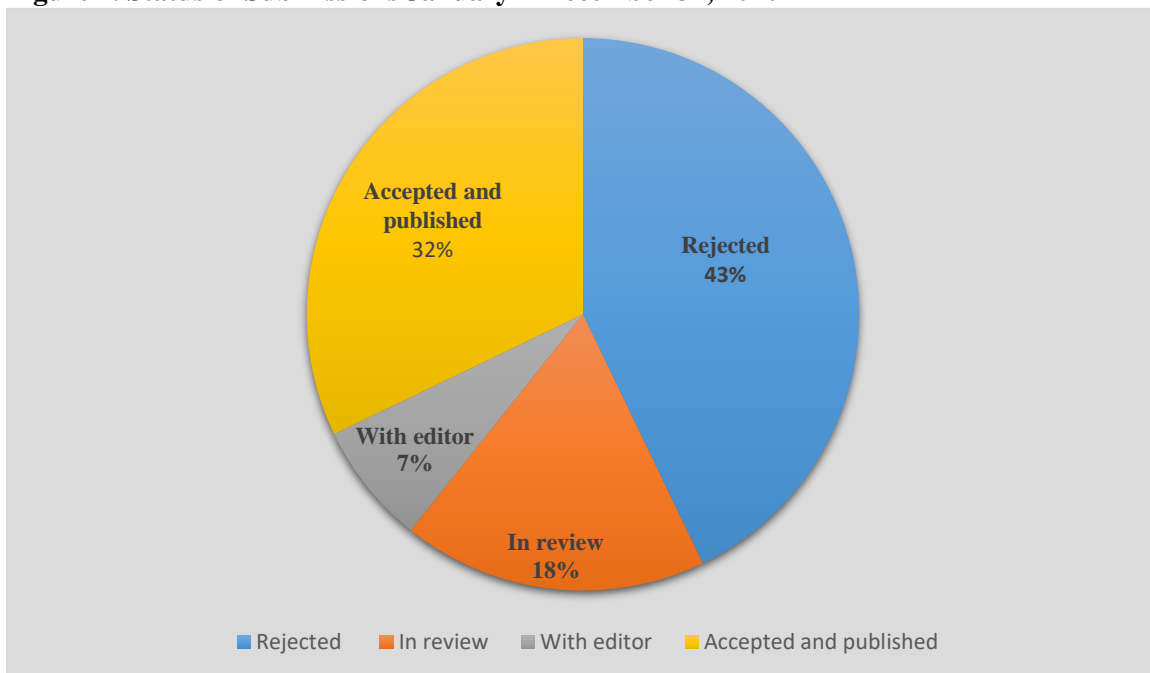


Table 2 is a four-year comparison of submissions. Two types of papers are submitted to the journal: research papers and “notes on operations,” which are “thoughtful explorations of operational issues that have value and implications for other libraries.”

Acceptance and rejection rates are reflected in tables 3 and 4. Table 4 is a comparison for the last four years. While the number of submissions for the last three years has not varied greatly, the rejection rate has varied.
