State Concern	In Empowering Learners: Guidelines for School Library Media Programs, AASL encourages the creation of a flexible 21st-Century learning environment and notes that "the use of multimedia and global resources can help create authentic learning experiences that teach 21st Century skills and connect what students are learning to the outside world." However, the reality is that in many schools, access to resources and experiences for students and teachers in the digital world are limited due to restrictions (filters, firewalls, bandwidth, etc.) imposed by technology coordinators without consultation or input from educators, especially from state credentialed school librarians. These library teachers have expertise in evaluating information resources and are in a unique position to apply standard selection criteria to determine the suitability of digital resources to support the curriculum, instruction and learning.

Connecticut school librarian Michelle Luhtala has surveyed schools regarding blocked sites. Ms. Luhtala is also spearheading a "Banned Sites Week" that will coincide with Banned Books Week.

State Concern	State libraries and education departments need accurate, timely, comprehensive data in order to assess their school libraries.  United States Code Title 20. Education, Chapter 76. Education Research, Statistics, Evaluation, Information, and Dissemination, Subchapter i> Education Sciences Reform, Part C. National Center for Education Statistics, Section 9543, Duties, 1 states, "The Statistics Center shall collect, report, analyze, and disseminate statistical data related to education in the United States and in other nations, including (1) collecting, acquiring, compiling (where appropriate, on a State-by-State basis), and disseminating full and complete statistics"  • Paragraph 1 states, "the existence and use of school libraries" shall be a set of data collected, and  • "Paragraphs 4 states that the Statistics Center mandate includes "assisting public and private educational agencies, organizations, and institutions in improving and automating statistical and data collection activities, which may include assisting State educational agencies and local educational agencies with the disaggregation of data and with the development of longitudinal student data systems;  • staff from numerous state library agencies and state departments of education have created a standard set of data elements and definitions in expressed intent to conduct an annual report of all school libraries;  • this standardized annual school library report project fits within the mandate of the Statistics Center.
Action (if any) taken by Affiliate Organization	Twenty states (Alaska, Florida, Idaho, Indiana, Iowa, Kansas, Kentucky, Maine, Michigan, Minnesota, Missouri, Montana, Nevada, New York, North Carolina, South Dakota, Utah, Vermont, West Virginia, and Wyoming) have met individually, as well as a large group, and expressed concern about strengthening and improving education through the effective use of statistics in educational media and the need for consistent, national data collection.
Action Requested of AASL	Our request is that the American Association of School Libraries request the National Center for Education Statistics to collect and disseminate quantitative information about the school libraries at the national, state and local levels more frequently than a four-year cycle that has occurred in 2000, 2004 and 2008.

State Concern	While the Standards for the 21 <sup>st</sup> Century Learner and Learning4Life have been in place for several years, adoption by school librarians is languishing. New school librarians entering the profession are not universally well-prepared to implement L4L; the current ALA/AASL Standards for Initial Programs for School Library Media Specialist Preparation were last updated in 2003 and do not reflect the new standards.  Additionally, practicing school librarians need a way to promote their own adoption of Learning4Life, which will help spur further understanding and adoption of the standards
