### **Major Accomplishments:**

Starting 14th year as Library Director of an independent, public library district with taxing authority (three-facility library system serving 180K residents covering 62 square miles; \$9M annual budget; staff of 150 (60 FTE); 2M annual circulation; 150K active cardholders; 500K item collection). Completed strategic plan; revised all policies; issued/refunded bonds six times; purchased leased building; preserved sub-regional library for the blind on a contractual basis; held operations steady with \$1.1M (20%) loss of property tax revenue; developed long-term financial forecasts; started annual fundraiser; obtained \$1M in cumulative grants from Friends; oversaw the purchase, programming, design and construction of a 20K s.f. branch library (2014); helped secure a voted 40% supplemental tax levy increase (2014); represented one of 60 libraries selected nationally to pilot the White House ConnectED Library Challenge Initiative (2015–16); overseeing programming, design and construction of new 28K s.f. branch to open in 2021. Developed two MOOCs, "Budgeting and Finance for Public Libraries" and "Strategic Planning for Public Libraries" on edX for the UMSI (2017). Led three grassroots tax levy efforts in three years to restore library services for home community (2011). Led MLA protest rally on state capitol against cuts to statewide library funding (2009). Obtained funding for five PLA SPECTRUM scholarships (2005).
