Statement of professional concerns

ALA is currently undergoing a much-needed period of self-criticism and review of how it does business and where it chooses to focus its efforts. As libraries and library workers have widened the scope of their social mission to better address the needs of and engage with their communities, ALA has not kept up. Conducting business as usual is neither sustainable nor a realistic model of what is needed and it shows in the association's membership numbers and financials.

- As Chair of the Rainbow Round Table, 2018-2019, I continued the work begun by Past-chairs Deb Sica and Jen Maguire-Wright in changing the name of the Gay, Lesbian, Bisexual, and Transgender Round Table to the Rainbow Round Table, drafting the language for the Spring 2019 ballot for this vote, having it approved by the RT's Executive Board, and having the name change voted on by members be approved by ALA's Committee on Organization.
- In response to member feedback, spearheaded discussions between the Executive Board and all
 five book committees (Stonewall and List) regarding the possibility of going virtual in order to be
 more inclusive of members wanting to participate. After much discussion, I led the decision to
 have the Over the Rainbow and Rainbow Book List Committees go virtual beginning in 2020.
 Expanded the number of committee members in all five committees to accommodate member
 interest and workload.
- Worked with Over the Rainbow and Rainbow Book List Committee members and chairs and Web
 Committee Chair to update the language on the committee pages, including charges and
 procedures to reflect the above changes.
- Worked with members and leadership of all five book committees and Web Committee Chair to edit language on their committee pages to be more inclusive.
- Worked with the Executive Board and Bylaws Committee Chair to update the RRT's Bylaws and Mission Statement to include the RT's new name, more inclusive language, and committee responsibilities updates.
- Worked with the Executive Board to revise, update, and approve the RRT's Leadership Responsibilities document.
- Drafted and received approval from the RRT Executive Board to release the (then) GLBTRT Statement against Racism, Harassment, and Bullying after the 2019 Midwinter Meeting.
- Worked with the Program Planning Committee to organize and facilitate the two GLBTRT (now RRT) 101 information sessions at the 2019 Midwinter Meeting and Annual Conference.
