What is FAST



Faceted Application of Subject Terminology



Subject terminology schema in libraries



The target of service is March 2019



The broad purpose of adapting the LCSH with a simplified syntax to create FAST is to retain the very rich vocabulary of LCSH while making the schema easier to understand, control, apply, and use. The schema maintains upward compatibility with LCSH, and any valid set of LC subject headings can be converted to FAST headings.

Vision Statement

FAST will be a fully supported, widely adopted and community developed general subject vocabulary derived from LCSH with tools and services that serve the needs of diverse communities and contexts. FAST Policy & Outreach Committee (FPOC)

Oversee	Oversee the community engagement, term contribution and procedures.	
Engage	Engage the community in developing and maintaining documentation; oversee the process.

How is FAST Being Used?

The British Library uses FAST in projects and workflows for which LCSH would be too expensive to assign. Staff on fixed term contracts can be quickly trained to apply FAST. The Library has also mapped a subset of FAST terms to DDC to speed up assignment of subject data to some electronic official publications and grey literature.

Columbia is also using FAST.

Cornell routinely assigns FAST headings to minimal-level cataloguing.

Brown University uses FAST to autoprompt controlled terms to authors of dissertations submitted to the repository. FAST was also used for retrospective assignment of controlled terms to a dissertation collection.

Michigan State uses FAST as the backbone for subject knowledge cards.

What do we need to deliver a sustainable, extensible FAST service

- Database served and permanently supported on OCLC production servers
- Editorial and development authority and policies
- FAST policy and procedure documentation and training resources
- Proposed management system
- Forum/communication channels for community
- Metadata validation system
- Resources to manage/evaluate proposals for changes
- Resources to manage MARC record maintenance
- Development resources
- Upgrade search FAST based on user feedback

What else does the community want?

The following ideas have come from community feedback and from the FPOC members:

- Capability to propose new terms and add scope notes
- An enhanced update mechanism approach for FAST
- LCSH to FAST conversion tools or services
- Capability to insert FAST headings into MARC records in Connexion, ILS, etc. from Search FAST
- Support use of alternate terms
- Capability to link to/from other vocabularies
