NARDAC

The North American RDA Committee (NARDAC) is the entity that represents the North American region on the RDA Steering Committee (RSC). NARDAC's membership for this period consisted of:

NARDAC's spring 2023 Update Forum was held April 3. It included an update on NARDAC activities by Clara Liao, and presentations by Adam Baron on the PCC SCT RDA Training Phase I, Ahava Cohen (EURIG Chair) on grammatical gender issues in cataloging, and Honor Moody (RDA Examples Editor) on examples in the RDA Toolkit.

On June 23, 2023 at ALA Annual a joint preconference workshop with NARDAC and PCC SCT RDA Training Task Group was held: **Unlocking the Power of RDA**. It provided a preview of PCC RDA Training Task Group Phase I work introducing some new and challenging terms/concepts in the official RDA with examples and exercises.

Four NARDAC (Liao, Maxwell, Polutta, Schiff) members participated in the MGD SES (string encoding scheme) writing starting in April 2023. The initial versions of these MGDs are expected to be completed in July 2023.

Upcoming: NARDAC Fall Update Forum (possibly in November). Possible content:

Activities

The RSC held two asynchronous (online) meetings January and July and an in-person meeting in Chicago in May

The January RSC meeting had a very light agenda and most of what was discussed also came up in the May and July meetings (see below).

At the May meeting the RSC discussed:

- Internationalization, including ways to integrate better with regions that are not yet represented on RSC (Latin America, Africa, Asia)
- Agreed that Original RDA will be “retired” around May 2027, after which it will be archived but no longer available online.
- Discussed what to do with “soft-deprecated” elements (these are elements that will still exist in Official RDA but have been replaced by other, preferred elements)
- Discussed and partially approved a proposal from the RSC Places Working Group revising some wording related to places, e.g. “governance” or “government” instead of “jurisdiction” to avoid confusion
- Continued discussion of the “community resources” section of the Toolkit
- Discussed future arrangements for the examples, including
 - Possibility of having more than just the examples editor working on examples
 - Suggestion that translators should be free to formulate their own examples
- Proposed a Task Group to find string encoding scheme instructions in RDA and make recommendations

At the July meeting the RSC discussed:

- Making the Education and Orientation Officer a permanent position (currently it’s temporary)
- Recruitment of a new Examples Editor (Honor’s term is ending this year)
- Instituting a Standing Working Group on Examples, which will assist the Examples Editor
- Continued discussion of establishing a String Encoding Schemes Working Group
- Drafted a survey on soft-deprecated terms, to find out which agencies will continue to use them (the survey will go some time in the near future, presumably before the end of the year)

An extension of the July meeting will take place via a public Zoom call on August 2 to discuss two proposals:
