# Shared Features

### **Board of Directors *Composition***

---

- President
- President-Elect
- Immediate Past President
- Treasurer
- Executive Director
- 1 Division Member
- 1 Round Table Member
- 1 Member from the National Association of Librarians of Color
- 1 Chapter Member
- 3 At-Large Members

### **Board of Directors *Term Lengths***

---

- 3 year staggered

### **Councilors/Assembly Member *Term Lengths***

---

- 3 year staggered
- Councilors/Assembly members may serve up to 2 consecutive terms

### **Board of Directors *Meeting Frequency***

---

- Monthly  
(1 in-person at ALA Annual, 1 hybrid at LLX, 1 additional in-person meeting, and all others virtually)

### **Councilors/Assembly Member *Meeting Frequency***

---

- 4 times per year  
(3 virtual, 1 hybrid at ALA Annual)
