

# Goals of the URIs in MARC Task Force

---

- ❖ Create a migration path from MARC to linked data
  - MARC infrastructure will not be going away soon
  - not everyone will move away at the same time
- ❖ Consistency of implementation of URIs in MARC fields/subfields
  - \$0 use becoming much more common
  - implementation can be inconsistent since we lack best practices
- ❖ Open up the possibility of using other vocabularies (e.g., ISNI) and entity registries
- ❖ ***Not...***
  - to make MARC a perfect carrier for linked data

# Why now?

---

- ❖ Focus on metadata models and services that are linked-data-oriented
  - RDA
  - Faceted vocabularies (MeSH, FAST, LCGFT, LCDGT)
  - Aggregators (ISNI, VIAF, Casalini, others)
- ❖ System functionality
  - New generation of ILS's
  - Limitations of string-based authority control
  - Authorities as a cross-platform requirement

- ❖ Support conversion of MARC data into linked data (LD4L/P, LC, OCLC Research)
- ❖ Build & encourage adoption of tools and services for linked data reconciliation (OCLC, LD4L/P, Terry Reese, Gary Strawn, Backstage)

- ❖ Enhance MARC capabilities (BL, DNB)



# URIs in Authority Records

---

## *Recommendation:*

- ❖ Permit use of subfields \$0, \$1, and \$4 in LC/NACO authority records in fields in which they are valid
  - Requires revision/updating of The *LC Guidelines Supplement to the MARC 21 Format for Authority Data*

# URIs in Authority Records—Current

---

- ❖ For some fields URIs can already be added in \$0 (e.g., 034 and 043)

043 ## \$a e-gx--- \$0 <http://id.loc.gov/vocabulary/geographicAreas/e-gx>

- ❖ \$0 already validates in OCLC in some fields where the *LC Guidelines Supplement* says not to use it or to “Consult LC’s Cooperative Programs Section before using”

# URIs in Authority Records—Potential

---

- ❖ Permit URIs in \$4 of 4XX fields if relationship designators are developed for variant name relationships

*Hypothetical example:*

100 1# \$a Clinton, Hillary Rodham

400 1# \$4 [URI for relationship] \$i Name before marriage: \$a Rodham, Hillary Diane \$w r

*Example from GND (German Authority File)*

# URIs in Authority Records: 024 Best Practices

---

## 024 field Other Standard Identifier as a test case

MARC Authority Format 024 Other Standard Identifier does not define subfields \$0, \$1, and \$4 as valid subfield values, but does define subfield \$2, Source of number or code

You may have seen identifiers recorded in the 024 field of NACO authority records:

# URLs in Authority Records: 024 Best Practices

## DCM Z1, 024

### 024 Other Standard Identifier

#### General

LC/PCC catalogers are encouraged to add standard identifiers in [field 024](#) if these are readily available.

When adding the 024 set [indicator 1 to 7](#) and add a [subfield \\$2](#) with the appropriate [Standard Identifier Source Code](#) for the identifier.

Input the number in the structure as determined by the agency formulating it.

Example:

```
024 7# $a 8462832856536435 $2 isni  
[number may display as: 8462 8328 5653 6435]
```

#### Maintenance

LC/PCC catalogers are not required to maintain identifiers coded in the [024 field](#) of NACO authority records. When an [024](#) identifier (e.g., ISNI, ORCID) is present in a personal name record that is being reported for deletion (for example, in the case of a duplicate), LC/PCC catalogers should transfer the identifier to the record that is to be retained. When two personal name authority records are being collapsed into one, and each record has its own identifier, LC/PCC catalogers should include both identifiers (in separate [024 fields](#)) in the updated record.

# URLs in Authority Records: 024 Best Practices

---

Although the addition of standard identifiers in the 024 field of NACO authority records is encouraged, existing documentation and examples only show the addition of the identifiers themselves, not a machine-actionable form of the identifier.

Compare this:

024	7		0000000118661438	#2 isni
-----	---	--	------------------	---------

With this:

# URLs in Authority Records: 024 Best Practices

---

## *Proposed assertions under consideration:*

- ❖ “The PCC URI Task Group supports the use of actionable URI’s in the MARC Authority Format 024 (Other Standard Identifier) field.”
- ❖ “When both an identifier and an actionable URI for the same entity are available, the PCC URI Task Group recommends recording both, in separate 024 fields.”

# Recommendations

---

- ❖ Develop implementation plan for \$0, \$1, and \$4 in bibliographic records
- ❖ Develop best practices and related training material.
- ❖ Permit use of \$0, \$1, and \$4 in NACO authority records.
- ❖ Develop plan for ongoing maintenance of Task Group outputs.
- ❖ Develop a process to evaluate and endorse vocabularies for PCC use.
- ❖ Include URIs when implementing PCC-endorsed vocabularies, e.g. ISNI and LCGFT.
- ❖ Clarify protocols for PCC MARC discussion papers and proposals.
- ❖ Identify issues that arise in related PCC efforts, such as specifications for converting MARC to linked data, and coordinating the work of the relevant groups.
