Statement of Professional Concerns:

Inequitable access to information helps to perpetuate economic divides within our society. Communities that have limited access to the internet and information sources are often impoverished and communities of color. Inequitable access to information limits people's ability to gain the information they need for lifelong learning and employment which negatively impacts the quality of life. As libraries continue to be underfunded within these communities, the problem of information disparity continues to exist. Paywall content such as newspapers and academic journals, limit access to only the privileged, leaving disadvantaged populations starved for information. This is a concern for our profession, as we promote learning and free information access for all people.
